

User agreement

1. General provisions

1.1. This User Agreement (Further Agreement) regulates the relationship between the owner (further operator) of the website <https://pizzobeachclub90g.com>-Next Site) on the one hand and the user of the site on the other. This agreement is also drawn up in accordance with the requirements of the Federal Act of 27.07.2006. No152-FH "On Personal Data," the Regulations of the European Parliament and the Council of the European Union 2016/679 of April 27, 2016 on the protection of individuals in the processing of personal data and the free circulation of such data and determines the procedure for processing personal data and measures to ensure the security of personal data.

Using the Site, the User agrees to the terms of this user agreement. If you do not agree with any item, please do not use the Site.

2. The basic concepts used in the Agreement

2.1 Automatic processing of personal data - processing personal data with computer technology;

2.2. Blocking personal data is a temporary halt to the processing of personal data (except if processing is necessary to clarify personal data);

2.3. Website - a collection of graphic and information materials, as well as computer programs and databases that make them available on the Internet at a network address <https://pizzobeachclub90g.Com>

The Personal Data Information System is a collection of personal data contained in databases and the information technology and technology that processes them;

2.5. Personal data processing - any action (operation) or set of actions (operations) committed using or without the use of such means with personal data, including collection, recording, systemization, hoarding, storage, refinement (update, change), extraction, use, transfer (distribution, provision, access), anonymization, blocking, deleting, destroying personal data;

2.6. Operator - Owner of the site, independently or in conjunction with other persons organizing and/or processing personal data, as well as determining the purpose of processing personal data, the composition of personal data to be processed, actions (operations) committed with personal data;

Personal data is any information that relates directly or indirectly to a specific or defined Site User;

2.8. User - any visitor to the Site;

Providing personal data is an action aimed at disclosing personal data to a particular person or a certain number of persons;

3. Rules of Use of the Site

The user has the right to:

Search for information on the site

Get information on the site.

Copy information to other sites with a source.

Copy information to other sites with permission from the Site Operator.

Require the administration to conceal any information about the user;

Require the administration to conceal any information from the user-provided site;

Use the site's information for personal non-commercial purposes with the permission of the Operator;

Use the site's information for commercial purposes with the permission of the Operator.

Use the site's information for commercial purposes with the permission of rights holders;

The site operator has the right to:

At your discretion and need to create, change, repeal the rules;

Restrict access to any information on the site

Create, modify, delete, delete information- delete accounts

Refusal to register without explanation;

The user undertakes:

To ensure the accuracy of the information provided;

To ensure that personal data is safe from third parties' access;

To update the personal data provided at the time of registration, if it changes;

Don't copy information from other sources.

When copying information from other sources, include information about the author;
Do not disseminate information that seeks to promote war, incite national, racial or religious hatred and hostility, or other information for which criminal or administrative responsibility is for dissemination;
Don't disrupt the site' health
Do not take actions aimed at misleading other users;
Do not use scripts (programs) to automatically collect information and/or interact with the Site and its Services;
The site operator undertakes:
Maintain the site as if it is not possible for reasons beyond the Operator's control.
Protect information that is restricted or prohibited by law by issuing a warning or deleting the account of a user who has broken the rules.

4. List of Personal Data Of the User That Can Be Processed by the Operator

The operator can process the following personal data:

- 4.1.1 Family name, name, middle name;
- 4.1.2. Email address;
- 4.1.3. Mobile phone number;
- 4.1.4. Images, including a personal photo of the user;
- 4.1.5. Knowledge of gender, citizenship, details of the identity document of the citizen;
- 4.1.6. Taxpayer's identification number, date of registration, details of the certificate of registration in the tax authority, other documents (OGRN or OGRNIP);
- 4.1.7. Address of the actual place of residence and registration at the place of residence and/or at the place of residence
- 4.1.8. The site also collects and processes anonymized visitor data (cookies, user's ip address, digital footprint) using Internet statistics services (Yandex Metrics and Google Analytics and others).

The above data, further on the text of the Agreement, are combined with the general concept of Personal Data.

4. Personal data processing goals

- 4.1. The purpose of processing the User's personal data is to conclude, execute and terminate civil contracts; provide the user with access to the services, information and/or materials on the website.
The Operator also has the right to notify the user of new products and services, special offers and events.
- 4.3. Impersonal user data collected through Internet statistics services serve to collect information about users' actions on the site, improve the quality of the site and its content.

Legal grounds for processing personal data

- 5.1. The operator processes anonymized personal data (p.4.1.8. Agreements) of the User when he visits the Site, if allowed in the User's browser settings (includes the preservation of cookies and the use of JavaScript technology), and the rest only if they are filled out and/or sent by the User on their own through special forms located on the Site. By filling out the relevant forms and/or sending their personal information to the Operator, the User also expresses his agreement with the provisions of the Agreement.

6. How to collect, store, transmit and other types of personal data processing

The security of personal data processed by the Operator is ensured by implementing the legal, organizational and technical measures necessary to fully comply with the requirements of applicable data protection legislation.

- 6.1.1. The operator ensures the safety of personal data and takes all possible measures that exclude access to the personal data of unauthorized persons.
- 6.1.2. The User's personal data will never, under any circumstances, be transferred to third parties, except in the case of the implementation of applicable law.
- 6.1.3. If inaccuracies in personal data are identified, the user may update it on his own by sending a notification to the Operator's email address marked "Actualization of Personal Data."

The processing period for personal data is unlimited. The user may at any time withdraw their consent to the

processing of personal data by sending the Operator an email notification to the Operator's email address marked "Recall consent to the processing of personal data."

7. Responsibility of the parties

7.1. The user is personally solely responsible for the information he disseminates

The operator is not responsible for the veracity of information copied from other sources

7.3 Operator is not responsible for mismatch between the expected user and the services actually received

The operator is not responsible for any services provided by third parties.

Final provisions

8.1. The user can obtain any clarification on the issues of interest related to the processing of his personal data by contacting the Operator via email.

This document will reflect any changes in the Operator's personal data processing policy.

The agreement is valid indefinitely until it is replaced by a new version. This agreement comes into force in any use of this site. The agreement ceases to apply when a new version of it appears.

The Operator reserves the right to unilaterally amend the agreement as it sees fit.
